Failure to meet the July 15 deadline will result in your unit being ineligible to receive Honor Point 16.

A county that does not comply with the above or does not send the Delegate Sheet to the Membership Clerk by July 15, cannot have delegates certified after arriving at the Annual Council. In the absence of certified delegates, only alternates as listed on the delegate sheet, as selected by the county can be approved as delegates after arriving at the Annual Council Meeting.

If a county does not comply with the above, or does not send the completed Delegate Sheet to Karen Nicholson by July 15, she will then so notify the Regional Director of that county of the failure of such compliance.
