



Legislative News

By the time you read this, the election will be over. We should be working on several fronts. First and foremost, the governor has proposed an additional raise for state and school employees. This is the 4th one and he suggested there will be a 5th before he leaves office. We ALL need to contact his office again and remind him that he is leaving retirees out of the picture. Retirees are suffering under the same inflation as the actives and while active employees have received several raises over time, most retirees have received nothing. **Please call the governor's office at 844-489-1348 and ask him to include a \$1,500 supplement for all retirees 70 and older who have at least 20 years of service.** Emphasize that retirees should **NOT** be forgotten again. Please use this number instead of calling the governor's direct line so we can track the number of calls we are getting. AARP WV is supporting us in this effort and are supplying us with this line.

The other effort we need to make is to identify our new legislators. All 100 of our Delegates were up for election and all of them are now in single delegate districts. This makes many of the districts smaller and more local. We need to identify members in each delegate district who as constituents of that delegate will contact them and get them a copy of our legislative goals. We need to do the same for our senators, but we would like to have someone from each of their counties to contact each of their senators. Note that there are also new senatorial districts now that the districts have been changed since

the census. It makes it a lot easier to work with legislators that have heard the message from home. The best way to contact your legislator is in person, by phone, or by mail. Emails are usually ineffective, especially during the session. Some legislators receive too many emails to effectively respond to or to even read. You can ask to meet with them after the election, call them, or write a hand-written letter which includes a copy of our legislative goals. One early way to find an address for your senator or delegate is to check the Secretary of State's website for candidate listing. It is <https://apps.sos.wv.gov/elections/candidate-search>. Please note this includes both winners and losers, so identify who won before checking them this way. As we get nearer to the legislative session, we will be working on getting better information out to you. Contact your county legislative chair and let them know you are available to help. Please share WVARSE legislative goals with your legislators.

State Goals

That WVARSE will promote legislation to continue and maintain the quality of PEIA coverage, without increases in premiums, copays or reduction in benefits.

That WVARSE will promote legislation to increase the pension of those who retired 20 or more years ago by two dollars per month per year of service.

That WVARSE will support legislation to provide a one-time supplement of \$1,500 for retirees 70 and over who had at least 20 years of service.

ONE ROOM SCHOOLS IN HAMPSHIRE COUNTY



HCARSE members and friends met on October 10, to explore the locations of one-room schools in the county. Robert Smith retired teacher of Augusta served as leader and guide. After visiting with Eddie Kidwell, we learned there were two Vinita Schools located in close proximity. One school was destroyed by fire; the other still survives in Higginsville on Kidwell property. Davis Adkins – Director of Regio VI



Dave was born and reared in Cabin Creek, WV, the son of a coal miner. He attended a three-room neighbor-

hood grade school. He continued his education at Leewood Junior High School and East Bank High School where he graduated in 1956. Dave was very active in sports throughout his school years. During his senior year at East Bank, he was selected to the All-State Baseball Team. As a freshman, he entered West Virginia Institute of Technology on a football scholarship where he played football and baseball all four years. Dave began his teaching career at Harper's Ferry High School in Jefferson County, where he taught Social Studies and Physical Education and was the assistant football coach. During the summer he worked on a master's degree in administration at West Virginia University. In 1961 Dave

was employed at Harrisville High School in Ritchie County as head coach of football, baseball, and basketball. While at Harrisville the athletic program was quite successful. One year they were 9-1 in football and in 1963 Harrisville High School won the State Baseball Championship. Next, he was appointed as head coach and teacher at Mt. Hope High School in Fayette County. Again, the athletic program was very successful. They were the runner up in the State Football Championship and in two consecutive years Mt. Hope High School won the State Track Championships. After five years of coaching and obtaining a master's degree, he returned to East Bank High School as Vice Principal.

Later he served as Principal of Harrisville High School. After that, he was offered the principalship of Petersburg High School in Grant County. After one year he was assigned the position of Assistant Superintendent, retiring in 1989 as Superintendent of Schools at the age of 51. He thoroughly enjoyed his career in Education and felt that it was an honorable and rewarding profession. Dave was well rounded in sports - he was an avid golfer and served on the Courtesy and Safety Ski Patrol at Canaan Valley for many years. Dave with his wife, Patty has traveled in every mainland state and Canadian province on their Goldwing motorcycle. As they continue to age, they still travel but now it's by automobile.
