# **AMBA ROUND-UP 2019**



San Antonio, Texas will never be the same again! "Why?", you ask? Because WVARSE Executive Director Bill Milam and President Mary Ann Ferris recently attended the AMBA Round-Up in that fine city with Richard Rowland, our region's AMBA director, and the other AMBA executives and Staff. Bill was attending his ninth Round-Up-his first in San Antonio- and Mary Ann was attending her first. What a wonderful experience and opportunity for your president! The accommodations were, of course, first class, but the most important part was the agenda that was packed full of speakers and sessions designed to help local and state associations increase membership.

The three key-note speakers were dynamic professionals

in their fields. Former Naval Commander Mike Abrashoff spoke about his "Leadership Roadmap". Upon accepting his assignment to the USS Benfold, one of the worst ships in the navy, he determined to change its reputation. He did this by developing a unique definition of leadership that involved every crew member on the Benfold so that they each felt ownership and pride in their work. He shared his methods and journey with the group. Jan Hargrave, the second speaker, a behavioral authority and body language expert, illustrated how our bodies communicate with the rest of the world by using humorous anecdotes. She even gave a "quiz" to help determine who was "right brain" or "left brain" to show how to make decisions and interact with others. Gabe Sonnier, the third

speaker, held all spell-bound with what he termed "God's Story" that chronicled his life from janitor in his neighborhood school to teacher of same school and later its principal. He is now an AMBA employee. He has received national recognition for his accomplishments. However, the speakers were just a small part of the conference. The entire conference offered a wealth of helpful information about membership recruitment and retainment. Most every state and local association face the same challenges. There were panel discussions whose members shared their successes and breakout sessions to provide small group discussions. Mary Ann took pages of notes with some new ideas to try. Mary Ann was the first WVARSE president to be invited to a Roundup an at the conclusion of the last session, she expressed her gratitude to Richard Rowland again for inviting her. Scheduled meeting time restraints and rain prevented their being able to visits historical places, such as the Alamo and Milam Park. Milam Park was established to honor the first Texan hero - Colonel Benjamin Rush Milam, first cousin (five times removed) of Bill Milam. His statue is erected at the park.

Constitutional amendments proposed. The first one to make the standing chairs: Community Service, Legislative, I&P and Membership members of the Board without having to be invited by the president passed. The second amendment to raise lifetime dues to \$150 failed. The three Legislative goals proposed by the Legislative committee were accepted for the 2019-2020 legislative session. The first goal about PEIA has been accomplished since the Finance Board has already announced that there will be no changes in coverage for any insured by PEIA. John Taylor our WVARSE Legislative chair has already started working on the second goal to raise the pension of those retirees who have been retired 20 or more years by \$2 per month times their number of years' experience. We will be asking for all of you to help again as you did last by contacting your local legislators. Our work on our third goal to collaborate with AARP on their campaign to Stop RX Greed will begin soon as the WVARSE Regional Directors and Regional Legislative chairs join the AARP Advocacy team (which contains several WVARSE officers and Board members) in Charleston on October 28 & 29 for a strategy session. These goals are ambitious, but we can ac-

She became Nationally Board Certified in Early and Middle Childhood Literacy in 2013. She is currently pursing certification in administration. As always, the Memorial service rated high. The Memorial service was well planned and executed. This is always a solemn ceremony. At the end of the Council, we

had a change of positions. Directors for Region I, III, and V were up for elections. Charmel Radcliff ran for Region I and was reelected. Carol Williams ran for Region III and was reelected. Steve Bailey, Region V Director had served his two terms and couldn't be reelected. We thank Steve for his four years of dedicated service. Our goal of increasing the minimum pension benefit from \$500 to \$750 was successfully passed and signed by the

Governor. This affected only a small percentage of our retirees who deserved the long-needed increase. As we go into the 2020 legislative session, we will need the support of the membership in getting our goals passed. We hope you will be available to make calls, visits, etc. at a short notice. Unit Officers and Honor Points forms can be completed online and sent directly to me. Watch for an email from me when they are available online. We now have three ways to pay membership dues. 1. Pay the conventional way by paying State and Local dues to the unit membership chair. 2. Dues Deductible. Complete a dues deductible

form (printed in this issue) with the last four digits of your social security number and signature. This allows TRS to deduct \$1.67 per month from your pension income. This is a convenient way of paying dues with no worry. Dues will be paid as long as you live. 3. Go to our website (WVARSE. org) and click on "Membership" on the next page find "pay online" and click it. Complete the form and pay either by Credit/Debit card or a withdrawn from your checking account. Membership is important to our organization. Going back a few years to Betty Daugherty's slogan "Each One Reach One".

complish them if we work together. Also, at the Annual Council Banquet, we presented House Majority Leader Amy Summers with the Bill Hammond Legislative Champion plaque for her support of our pension increase in the 2019 session. Senator Dave Sypolt was unable to attend the Banquet; so he received his plaque at the October Taylor county ARSE meeting. Thanks to the efforts of these lead sponsors, our bill passed both Houses of the Legislature without a dissenting vote. I understand that we retirees received some criticism on Facebook for these award presentations from a few active teachers. I guess they felt we retirees had betrayed them. However, I do not see these awards as anything other than our appreciation for helping WVARSE achieve our main legislative goal. WVARSE is a RETIREE organization whose primary goal is to work for retirees;

this is what we did. However, we DID support the active education employees in various ways without jeopardizing our bill's passage. The WVARSE Board prepared talking points that included all the things that the employees wanted and what they opposed in the Education Bill for our Board members to use to testify at the Public Forums on Education. At least one WVARSE Board member testified at each of the eight forums, and I personally submitted written comments containing the facts that the active employees had proposed. At the business meeting of Annual Council, there was a motion to include a student entering A Vo-Tech program in one of the four WVARSE scholarships. This motion passed, and I asked for volunteers to serve on a committee with Scholarship chair Sharon Vance to establish the criteria for this scholarship. By the time you read this Newsletter, this committee of fourteen will have had its initial meeting on October 24 at the Sutton Senior Center. Also, at this session, we awarded the first Rita Hammond Membership plaque to Grant county for having a 42% membership increase. Congratulations to Grant county and Erma Moyers their Membership chair for all their hard work. I also congratulate Brooke, Tyler, Gilmer, Glenville State, Roane, Wirt, Nicholas, Berkeley and Mineral counties for increasing their membership. Keep up the good work! I now challenge all the other counties to work just a little harder to increase their membership; you can do it if every WVARSE member recruits one new member. Remember that WVARSE membership is cheap if you use the AMBA benefits that our members are eligible for. Remember also that WVARSE is always working on protecting our retirees' interests and benefits. In that vein, WVARSE Executive Director Bill Milam and Legislative chair John Taylor will be in Washington, D.C. on October 23 & 24 to

present WVARSE Resolution and letter proclaiming WVARSE's opposition to the Health Insurance Tax (HIT) and the Medicare tax. Hopefully our efforts will prove fruitful once again. John Taylor and I also plan to attend the remaining sessions of the PEIA task Force Committee's meetings. Although it's been months since their last meeting, they have not yet finalized their report which has to be submitted to the Governor and the Legislature by December 31. Even though we cannot speak, our presence reminds them to take care of us retirees. As I conclude this message, I urge you to take care of yourselves and your families. I wish speedy recoveries for all our WVARSE members and their family members who are ailing. Enjoy the upcoming holidays with your family and friends, and especially enjoy each day of your because it is a gift; that's why they call it the present. Most of all remember to SMILE.

One subject closely related to WV AARP's goal, The High Cost of Prescription Drugs was discussed, and John and I discussed this with each of our Federal legislators during our visit on Wednesday afternoon, On Wednesday afternoon, we visited the offices of our two Senators and Three Representatives. Due to their schedules, we were not able to meet with the legislators. We did, however, have good meetings with aides of each of our federal legislators. John talked with each office about the high costs of drugs and shared with them a personal story. We delivered to each office a letter from WVARSE president, Mary Ann Ferris along with the HIT resolution from WVARSE. Each office listened to us and assured us that their office was concerned about HIT and that they were supportive of either elimination or continued postponement of HIT. We were honored to be able to use the underground rail to travel from the Senate buildings to the Representative buildings.

## Retired School Personnel Renovate Mouse Run School



Members of the Barbour County Association of Retired School Employees are shown planning the annual cleaning and repair projects on the historic Mouse Run School during August in preparation for the recent Barbour County Fair. Each year, the local chapter donates the necessary labor, supplies and materials to help protect the pre-Civil War era structure. BCARSE sponsors the structure and the related open house activities in late summer. During the last week of August, local elementary students and scores of other visitors from Barbour and surrounding counties and several other states visited the school and heard stories about the school's history and operation. The Mouse Run Log School, a monument to early rural American education, was built in the 1840's on what is now the Bernard Everson farm on Mouse Run Road. The 17' by 30' one-room structure was one of the very first free schools to be constructed in the region. Following its donation to the BCARSE in 1984, the old school building was dismantled, transported to the Barbour County Fairgrounds, and then reassembled. When promised governmental funding for the necessary repairs and renovations failed to materialize, members of the association solicited donations of money, material and labor to secure and furnish the school themselves, with its dedication finally occurring on July 4, 1989. Thousands of visitors have since stepped back in time to envision the pupils, their surroundings and activities in this one-room log school of by-gone days.

# Harry Oswald Yates spent three Christmases in the US Army

After being drafted at the age of 20 Oswald left Monroe Co for Ft Knox Kentucky Dec 1, 1943. He spent his first Christmas at Ft Knox. After training he was shipped to Glasgow Scotland to "wait" for two weeks before departing on a landing launch ship for France. In France, Oswald was First Armor, 3rd Division, located behind the preliminary forces. Eventually his platoon was sent into fox holes. Being bored, or inquisitive he started roaming around. A First L stopped him, asked if he could drive, and gave him the assignment of being driver of a jeep which escorted the officers. Now he was in the 32nd Division. He spent an enjoyable time in Paris, delivering mail and driving officers around. Sometimes he went with them on vacations. He spent his second Christmas in France. Oswald was put in the 33rd Division which went into Germany at the Bulge. The troops crossed the river in pontoon boats. His jeep followed, dodging remnants of war. Unfortunately, he wrecked. All men in the jeep, jumped out and started running from enemy fire. Luckily, Oswald tripped. As he was going down, 3 bullets hit him from the back, but only one injured him. He never got back his full strength in the left arm. Those that survived were captured by the Germans, but the Allied Forces rescued them later. After a short time in hospital in France, he was promised in November that he would make it home by Christmas. Poor Oswald was put on a little "tub" just before Christmas and didn't make it to the states until much later. He spent his 3rd Christmas on the tub. He arrived in New York City on \_\_\_\_\_\_ and then home. His wife Doris Yates was not his sweetheart at the time, but she still remembers the young wounded soldier coming home in his uniform.
