### 2017 LEADERSHIP CONFERENCE SET FOR APRIL 26

The 2017 Leadership Conference will be at Flatwoods on April 26, 2017. It will be a one day conference, beginning at 10 AM. Registration will begin at 9:30 AM. The WVARSE Board, at the November meeting, voted to require a \$15.00 registration fee. Anyone can attend the Leadership Conference, but Unit Presidents (or Vice Presidents) and Regional chairs are expected to attend. There will be a free lunch served at noon. Scheduled to speak: Ted Cheatham, Director of PEIA and Jennifer Brown. National Institute on Retirement Security (NIRS) manager of research.

Ted Cheatham has had a varied career in the health insurance industry. His experience in the managed care arena has ranged from launching HMOs in the Los Angeles market and starting an HMO in Mississippi, to acquisitions, mergers and integrations in West Virginia. As a former CEO of commercial health plans, he has managed Medicaid programs, Medicare programs, and all facets of commercial health insurance products.

A stint as a business director and management consultant with Unisys, a worldwide technology services and solutions company, provided vital experience in the technology sector in his employing all of this experience to shape the future of West Virginia's largest self-funded group health insurance plan. PEIA provides health and life insurance to more than 200,000 active and retired public employees and their dependents. A U.S. Army veteran, Mr. Cheatham is a graduate of the University of Arizona,

where he earned a bachelor's degrees in finance and personnel management; Troy State University, where he earned a master's degree in business administration; and, the Whittier College School of Law where he earned a Juris Doctorate.

Ms. Brown joined the National Institute on Retirement Security in 2015. Ms. Brown conducts original research and analysis regarding issues related to retirement and is often quoted by the news media.

Before joining NIRS,

Ms. Brown worked at the U.S. Department of Labor. There, she worked on issues related to corporate transactions, financial products, and the Affordable Care Act. Additionally, Ms. Brown has held positions at Georgetown University Law Center as a researcher with the ERISA Legislative History Collection and several law clerk positions focused on pension and benefit plans and retirement policy. She is also a contributor to the Fifth Edition of the ERISA Litigation treatise. Additionally, she serves as Adjunct Professor at American University and is a Fellow with the Tax Policy Center at American University.

Ms. Brown holds an LL.M. in Taxation and a Certificate in Employee Benefits Law from the Georgetown University Law Center, a J.D. from the American University Washington College of Law and an M.S. in Law and Society from the American University School of Public Affairs. She earned a B.S. in Philosophy and Criminology from the University of Florida.

As I write this article, we still have eight days of the regular session of Legislature, and still no budget. We were successful in getting three bills introduced. They were: 1. SB 403, to add the \$2,000 exemption for retirees to the \$8,000 exemption granted all citizens 65 and older making a total exemption of \$10,000 for public retirees at age 65. 2. Sb 404, to increase

the \$2,000 exemption for retirees to \$20,000. 3. SB 498, a funding source dedicated to public retirees – a .5 % tax on Marcellus and Utica gas. All three of these bills were referenced to Senate Finance and were never place on the agenda. PEIA was a target this year. Three bills were introduced in the Senate. SB 221, to redefine qualification of board members. This bill, if passed, would just about eliminate all board members and replace them with new members. SB 221 passed

out of the Senate and was sent to the House, March 6, 2017. In the House, it was referenced to House Government Organization, and was passed out yesterday to the House with recommendation to pass. It is on first reading today, April 1. At this time, there has been no action to fund PEIA.

I encourage all Presidents and Regional Chairs to attend the Annual Leadership Conference April 26th. As last year, the Leadership Conference will be one day. Please see the schedule of events in another area of the newsletter. There will be a \$15.00 registration fee per person attending the conference. The Board took advantage of an opportunity to do a "blind mailing" to all retirees who had retired in the past 5 years. We apologize to those of you who had already joined, but we had no method of sorting out those who are members. Thanks for your understanding. As the result of this mailing, we had about 230 replies. We must continue to increase our membership.

It is the responsibility of each member to do his/ her best to enroll new members and retain old members. Your sharing email addresses with us would be most helpful. We prefer that you share your address with your unit and they will, in turn, share it with me. That way all concerned will have access. Many of my email addresses are not valid. If you have changed your email address, please send me an email at bmilam@suddenlink.net so that I can update my files.






#### WIRT COUNTY
