Well, not for lack of valiant effort, but we lost, and we lost. This year the AARP State Advocacy


Team worked hard supporting our efforts. I can't say enough about their efforts on our behalf. After consul-

ees. The Senate Finance Chair wanted to add a third qualifier to save most of the money that would cost. Basically, they wanted to limit the supplement to those whose pension was

EXECUTIVE DIRECTOR'S COLUMN

Another legislative session has ended without any-

thing being considered for retirees. SB 432 that would have provided a \$1,500 onetime supplement for retirees 70 and above who had at least 20 years of service was introduced by Senator Eric Nelson (Kanawha). We held high hopes that this had a chance of passing. It only had one reference - Finance Committee. It sat in Finance to near the end of the session. It was proposed to limit the supplement to those whose pension was \$1,000 or less per month. WVARSE leadership rejected this offer and the bill died. Two bills were completed during the 2022 Legislative session which affect PEIA: SB 205 • Expanding the PEIA Finance Board from 8 members to 10. One member who shall represent the interest of hospital, who shall have been employed by a hospital for a period of at least three years prior to appointment and shall remain an employee of a hospital for the duration of his or her appointment. The second member shall represent the interest of non-hospital health care providers, who shall have owned his or her non-hospital health care provider business for a period of at least three years prior to appointment and shall

maintain such ownership for the duration of appointment. This takes effect June 9, 2022. HB 4112 • Provides consumers a choice for pharmacy services. This takes effect June 10, 2022. We were not successful in getting legislation introduced to amend §5-10D-6. Voluntary deductions by the Consolidated **Public Retirement Board** from monthly benefits to retirees to pay association dues. This law allows the TRS to do blind mailings for retiree association and allows dues deduction. This law has an expiration date of July 1, 2022. WVARSE presently

has 178 members enrolled in Dues Deduction. I will notify each enrolled member prior to July 1, 2022, informing them their need to pay their membership another way. Paying online is a good option.

COVID-19 is not over, but it is milder, and most people feel comfortable meeting and attending functions. We will have a one-day Leadership Conference (May 4, 2022). We will have our regional meetings this year. We are hopeful that we will be able to hold a normal 2-day Annual Council.

We must continue to increase our membership. It is the responsibility of each member to do his/her best to enroll new members and retain old members. We still accept the old enrollment forms and members can enroll on the website. Your sharing of email addresses with us would be most helpful. We prefer that you share your email address with your unit, and it will, in turn, share it with me. That way all concerned will have access. Many of my email addresses are not valid. If you have changed your email address, please send me an email at bmilam@suddenlink.net so that I can update my files.

longer benefit most of our members. In working for broader coverage, we lost the bill. The chair never put it on his agenda. At least this will allow us to work for something next year that might have broader coverage and include more of our members. Thanks to Danny Gray, Bob and Nellie Orsburn, and many others too

numerous to mention who made contacts at critical times. We came close but didn't quite make it. It wasn't for lack of effort. The other bill we lost was an AARP bill that would have reduced the maximum insurance copay on insulin from \$100 to \$35/30 day supply of insulin. Although it passed both chambers in different forms, they couldn't get together on a single version before time

ran out. Basically, we live to fight another day. Retirees should not be forgotten most years in the legislature. Your efforts helped to get several cosponsors added to SB 432. Your grass roots efforts early enough may help to bring us to success next year. Our message that retirees were forgotten this year should be heard in every office in the Capitol well before the session next year. The

Governor should hear us. Everyone running for Senate or House this fall should hear us. The Senators that don't have to run this year should hear us. Don't forget, retirees again should be heard early and often. Together we can make a difference. We should have members at every political meeting asking candidates to commit to supporting retirees. Our grass roots need to get our message out.

Dear Editor:

This letter is written to express the extreme disappointment that WVARSE Executive Board members feel at the conclusion of the Legislative session. Despite repeated efforts of our legislative committee, chaired by John Taylor, and officers of our Board, retirees were not mentioned in the Governor Justice's legislative call. While we were pleased that active employees received a 5% pay increase, retirees were not included nor even mentioned.

When the Governor announced his intent to give active employees a one-time \$1500 stipend to help defray the rising cost of food, gasoline, etc. once again, retirees were not included in this proposal. At this point, our legislative committee asked all members to call the Governor's office to request that retirees receive the same stipend. We face the very same inflationary costs that active employees do; many of us with much less income than the actives who would receive the stipend. Despite our vigorous efforts which inundated the Governor's office with our requests, our efforts were to no avail. Granted, the active employees did not receive this stipend because they received the 5% raise in the budget which has passed both the House and Senate and now awaits the Governor's signature. We retirees got nothing. All our other efforts with the Legislature were just as fruitless (see Legislative article elsewhere).

Rest assured WVARSE officers, board and members will continue to diligently work on behalf of our retirees. We will work with Governor Justice's office, elected officials, and any other agencies to attempt to secure some part of the \$600 million budget surplus for our retirees. Be forewarned that we may call upon you once again to contact key people on a moment's notice to aid us in our lobbying efforts. Remember WVARSE's motto is "To Serve, Not to Be Served". We members of the Executive Board take that motto very seriously as we make every effort to serve you.
