WVARSE Scholarship Recipients Deal With COVID-19

COVID*19 affected our scholarship winners. Sharon Vance received the following comments from a couple of the scholarship recipients.

"Hello, I was able to complete my student teaching this spring despite the closing of the schools due to COVID-19. Instead of being in the classroom with my class of 4th graders every day, I met with them over Google Meets each day. Every morn-

ing I videotaped my self reading from a novel for the students to watch. The class read Shiloh, Maniac Magee, and Holes. During our video chats every day, I would lead a discussion about the chapters in the books that they read that day. These video chats also gave the students time to share what had been going on in their personal lives with each other. The students also completed comprehen-

sion worksheets via google slides that corresponded with each chapter. Students would email me their completed slides and I would check over them daily. On Fridays, I checked the students' weekly Friday letters in which they wrote a letter home to someone they were close with. This person would respond to the students. The students also had math assignments daily. Social studies and

science assignments alternated weekly. The students used their Chromebooks to complete these assignments via iReady, Ducksters, and Mystery Science. I also answered a lot of questions from parents using the class dojo app or email as the class transitioned to online learning." - **Jada Adlington**

"Hello! I was placed in a Title I school in Wheeling,

WV for student teaching. I was a year-long residency student, so I had the opportunity to be with my class my entire senior year. I was unable to finish out the school year due to Covid-19. This was not what I expected to happen during my student teaching semester! Many of my students did not have access to internet, so online assignments were not given. However, as time went by, we

were able to get a few students together to Zoom. We played games, talked about what we have been doing, and offered help with assignments. I am sad that I did not get to finish out the year with my kiddos, but this experience has allowed me to adapt to new circumstances. I feel more equipped to teach in the fall and am looking forward to being hired!" - **Calesha Williamson**
